MANAGER REPORT

Mr. Noriega presented the Board with a written report. Below are noted action items:

- Landscaping Serviced by JA&A Landscaping Company. No issues reported. The Palm Trees were trimmed on May 29.
- Pool Mr. Peterson and Mrs. Meyer are now servicing the Pool. Bob Divine continues to service the pool as the pool operator and Rosa's Janitorial Services cleans the Ramada and bathrooms. Reimbursed Mr. Peterson and Mrs. Meyer for their pool class.

BUSINESS

a. Ramada Improvement Discussion and Ratification - The Board ratified the decision to spend \$26,000.00 in renovating the Ramada, which includes more concrete deck and extending the roof over to the west side of the Ramada. All permits, architect fees, etc. are included with the price.

A motion was made to ratify the decision to improve the Ramada at a cost of \$26,000.00. The motion was seconded and approved.

- b. Pool Passes Mrs. Peterson asked if there was the need to have pool visitor passes. Mrs. Peterson added that there have been a couple of incidents where teenagers have been caught using the pool. Clearly, these kids do not live in the community, nor they are visiting anyone. The idea is to create a visitor pool pass. Discussion ensued regarding implementing a visitor pool pass. No decision was made, owners will be polled via email and newsletter.
- c. Hot Tub Health Warning Sign Mrs. Peterson stated that she would like to get a sign posted by the spa with the health warnings on using the spa. The sign will be ordered.
- d. Wildlife in Our Community Mrs. Peterson stated that wild animals are in the community, there is no avoiding them, we live in their territory. Please do not feed them.
- e. Nature of Property Inspections Mrs. Peterson stated that inspections are done by the Board, and they will talk to the owner regarding the violation, if the owner ignores them. Mr. Noriega will send them a letter of enforcement.
- f. Solar Installations There was a question if solar panel installation is allowed in the community. The answer is yes, they are, approval from the ARC is still needed but they are certainly allowed.

HOMEOWNER OPEN FORUM/COMMENTS

- > June Field asked if the cable boxes can be removed. Mrs. Peterson said no, the cable company needs to have them there. They are a utility and is needed.
- > The Monthly lunch is scheduled for July 18th, 2023.
