

WINDOW ROCK EAST POOL RULES - 2010

1. Pool and spa hours are 6:00 A.M. to 10:00 P.M.
2. All persons using the pool DO SO AT YOUR OWN RISK!
3. No lifeguard on duty; SUPERVISING RESIDENT ADULT ASSUMES FULL RESPONSIBILITY for family and guests.
4. Pool is for private use only. Proof of residency may be required.
5. Children under the age of 14 are not allowed in the pool unless accompanied by a responsible adult resident of age 18 or older.
6. Infants/toddlers wearing cloth or disposable diapers MUST also wear rubber or plastic swim wear pants over diapers.
7. Use of a life jacket or similar flotation device is recommended for small children.
8. Proper swimming attire is required in the pool. No jeans, cut-offs, or other street clothing allowed. Nudity/exposure is not appropriate in a family recreation area.
Proper swimming attire is defined as:
 - ***subject to approval by the security guard and/or Board of Directors***
 - ***non-transparent and***
 - ***must cover buttocks and breasts - speedos are acceptable. Thong swimming attire is NOT acceptable.***
9. Intoxication (alcohol and/or chemical) in pool area is prohibited.
10. No smoking is permitted in pool area.
11. Any person with a communicable disease or infection should avoid using the pool.
12. No food or beverages are permitted in the water at any time.
13. NO GLASS CONTAINERS OF ANY KIND are permitted in the pool area. Residents are responsible for clean up of any trash.
14. Safety equipment (life ring, rope, pool hook and signs) is required by law. It must not be handled, tampered with, or used except in case of emergency.
15. For your safety and that of others, when entering and leaving the pool area, the gate must be secured. The gate is not to be left ajar or tampered with at any time. Bathroom doors are to be kept locked after use.
16. The shower should be used to wash off suntan oils before entering the pool.
17. Horseplay, running, or any disturbing unsafe activities are not allowed in the pool or surrounding areas.
18. No pets are allowed in the pool area.
19. Skateboards, bikes, roller skates and similar items are not permitted anywhere in the pool area.
20. Battery-operated radios, cassettes, and CD players are permitted as long as the volume is kept low, so as not to disturb others.
21. Facility is for exclusive use of residents and their guests (maximum of 4) unless prior arrangements have been made with GNC Community Management, (520) 999-1725.
22. Guests must be accompanied by an adult resident, age 18 years or over. There should be one adult for every four children.
23. If homeowners wish to schedule a private party for the Ramada, during pool season and hours of operation, please contact GNC Community Management at (520) 999-1725 to schedule a date.

Neither Window Rock East Homeowners Association, nor GNC Community Management, is responsible for any stolen personal items. Rules are made for the benefit of the community as a whole, and a violation may result in the loss of pool privileges for thirty days or more, and a fine may be levied by the Window Rock East Board of Directors, pursuant to the Bylaws, and/or CC&Rs. Please report all pool violations to GNC Community Management at (520) 999-1725. Violations of posted safety rules will be strictly dealt with.
